INSTITUTE OF TOURISM STUDIES ACT (CAP. 566)

Scientific Committee Regulations, 2017

IN exercise of the powers conferred by article 27(8) and (9) of the Institute of Tourism Studies Act, the Minister for Tourism has made the following regulations:-

The title of these regulations is the Scientific Citation and 1. (1)scope. Committee Regulations, 2017.

(2) These regulations provide for the establishment of the Scientific Committee of the Institute for Tourism Studies.

For the purpose of these regulations and unless the context Interpretation. 2. otherwise requires:

"Act" means the Institute of Tourism Studies Act; Cap. 566.

"Board of Governors" means the Board established by article 9 of the Act;

"Board of Studies" means the Board established by article 11 of the Act:

"Institute" means the Institute for Tourism Studies;

"Minister" means the Minister responsible for Tourism;

"Scientific Committee" means the Committee that will focus on tourism and hospitality which shall develop and review the curriculum of the Institute by identifying essential competences of current and future workforce within the tourism and hospitality sector as established in regulation 3.

There shall be a Scientific Committee which shall Scientific 3. (1)Committee consist of the following members:

(a) the Head of Corporate Services of the Institute, ex officio, who shall act as the Chairperson of the Committee;

the Head of Academia of the Institute, ex officio, (b) who shall act as the Deputy Chairperson of the Committee;

(c) a member representing the Malta Hotels and Restaurants Association;

member representing the Gozo Tourism (d)а Association:

a member representing the Federated Association of (e) Travel and Tourism Agents;

(f) a member representing AirMalta;

member representing Tourism (g) the Malta а Authority;

a member representing the Malta Association of (h) Hospitality Executives;

(i) a member representing the Malta Chef Society;

a member representing the Malta Union of Tourist (j) Guides:

(k) a member representing the Valletta Cruise Port; and

a member representing the Malta Bartenders Guilds: (1)

Provided that the Board of Governors may allow the Committee to obtain any further expert or a group of experts to assist it in the performance of its functions as may be necessary.

(2) A person shall not be qualified to hold office as a member of the Committee, if that person -

> is legally incapacitated; or (a)

has been declared bankrupt or has made a (b) composition or arrangement with his creditors; or

(c) has been convicted of a crime affecting public trust or theft or fraud or knowingly receiving property obtained by theft or fraud, or of any offence against the Act or any regulations made thereunder; or

has a financial or other interest in any enterprise or (d) activity which is likely to affect the discharge of the functions as a member of the Committee.

4. The Scientific Committee shall have the following Functions of the functions:

(a) to develop and review the Institute's curriculum;

(b) to introduce and develop vocational education and training programmes for full time students;

to introduce and develop continuous vocational (c) education and training programmes for part time students;

to review and update existing training programmes (d)of the Institute;

to review and develop the implementation of (e) curriculum at the Institute; and

to review, promote and develop work-based learning (f) initiatives.

It shall be the duty of the Scientific Committee in Methodology. 5. exercising its functions to adopt a scientific methodological approach of the recommendation through the use of the following methods:

qualitative analysis through use of focus group (a) meetings;

(b) evidence-based research and reports;

comparative research; and (c)

quantitative analysis through the use of statistical (d) instruments.

The Scientific Committee shall periodically inform Report. 6. (1)the Board of Studies with any suggestions and, or recommendations and, or results for the purpose of developing, designing and reviewing of the training programmes and, or curriculum of the Institute.

(2) The Scientific Committee shall annually report to the Board of Governors the recommendations and, or results made throughout the scholastic year in fulfilment of its duties.

7. The Scientific Committee shall meet at least once Meetings of the (1)every month.

Scientific Committee.

(2) No business shall be transacted by the Scientific Committee unless a quorum of seven members is obtained.

(3) The Chairperson of the Scientific Committee shall regulate all proceedings and discussions and the Scientific Committee shall establish its own rules of procedure during its meetings.

(4) The Chairperson of the Scientific Committee may invite guests to attend the meeting as observers.

(5) The Scientific Committee shall reach its decisions through a simple majority vote:

Provided that in the eventuality that the votes are equally divided the Chairperson shall have and exercise a casting vote.
